State Patrol Presentation

Below are the question we submitted to the Wisconsin State Patrol and the answers they provided. If anyone would like a copy of the Power Point from the State Patrol, contact Jon Coutts.

Is a CDL required to drive a fire apparatus owned by a technical college?

Yes. Despite the fact that the school is a governmentally owned facility, it is NOT exempted under Chapter 343.

If students need a learner's permit is a Federal Medical Card required?

No medical required. They are exempt under 49 CFR 390.3(f) (2).

If firefighters aren't required to have a CDL to drive a fire apparatus from their department during an emergency, do they need one to drive a fire apparatus fro another department they don't belong to?

No CDL required. They are exempted under 49 CFR 383.3 (d) (2).

Is a CDL required to operate an apparatus during a parade?

If the apparatus is used INTER-state then yes. If the apparatus is used INTRA-state then they are exempted under state law "routine performance of other duties of the fire organization."

Is a CDL required to operate a fire apparatus during training or other non-emergent driving?

No, drivers are exempted under state statute 343.055 (1) (b)

If a CDL is required for the above questions can these be written into the driver's job duties so a CDL is not needed?

N/A. They are exempt in all cases INTRA-state. In the case of the INTER-state parade, no modification of job duties will clarify the requirements for a CDL.

Is a CDL required to cross state lines for a MABAS call, or is this covered in the MABAS rules.

No CDL is required, they are exempt under Federal Regulations 383.3 (d) (2).

Are fire departments exempt from State/Federal DOT regulations?

Government owned fire departments are exempt under state law and 390.3 (f) (2).

Privately owned fire companies are subject to all FMCSR's.

Are DOT inspections and pre-trip inspections required on fire apparatus?

Government owned vehicles are exempt.

Privately owned fire companies are required to have annual inspections and to complete/document POST trip inspections.

Trans 309 covers ambulances. Is there a chapter that covers fire apparatus and lighting colors?

No, there is no specific section to govern fire apparatus.

Are fire apparatus subject to DOT regulations for axle and tire load?

Yes, they are not exempt from any weight restrictions or tire load limits.

What is the minimum tread depth for drive and steer axles on fire apparatus? How is it measured?

Government owned vehicles are regulated at 2/32" tread depth on all tires.

Privately owned trucks are regulated at 4/32" on a steer tire, 2/32" on all others.

Tread depth is measured in two adjacent major tread grooves. Major treads grooves are identified as any groove containing a tread wear indicator.
